Library – Jessica Godfrey – Read a few highlights from their September newsletter for the library.

NOCA – No report was received. We did receive a copy of their budget for 2026.

<u>Planning Board</u> – Bill Joyce – Mr. Ehle was present at their meeting. He has plans to buy the property across the street from the old Rail City on Route 3. He would like to create a golf community with luxury apartments. Nothing has been brought forward in writing and Mr. Ehle has not purchased the property yet. We need to approve adding the Village of Lacona to the Sandy Creek Regional Planning Board. There was a discussion about reappointing Shirley Rice to the Planning Board but that is something the Village of Sandy Creek will need to do. The Village of Sandy Creek, Village of Lacona, and Town of Sandy Creek boards will need to have

a joint meeting to establish an Inter Municipal Agreement (IMA) between the three municipalities for the planning board.

WHEREAS, the Village of Lacona has expressed a desire to join the Sandy Creek Regional Planning Board and participate in coordinated planning, subdivision, and site plan review; and

WHEREAS, the Town Board ("Town Board") of the Town of Sandy Creek finds that the inclusion of the Village of Lacona will enhance regional planning and provide for efficient and consistent land use review;

NOW THEREFORE, IT IS HEREBY RESOLVED, the Town Board hereby consents to and approves the entry of the Village of Lacona into the Sandy Creek Regional Planning Board, subject to the execution of an intermunicipal agreement among the participating municipalities; and

IT IS FURTHER RESOLVED, that the Town of Sandy Creek Supervisor is authorized and directed to execute said intermunicipal agreement on behalf of the Town, subject to approval as to form by counsel; and

We do already have the domain name. Brittany will reach out to a few companies that have helped other municipalities with this transition.

Ron Fisher – Mr. Fisher handed out a map, to the Town Board, with the 2025 microcystin sample results. E-Coli testing is still ongoing. There is a presence of E. Coli, but it is not high.

PUBLIC COMMENT:

Nichole Wall – Local resident and works for a Community Energy Group – Ms. Wall spoke regarding possible solar credits that may be available for residents in our area. The credits could take about 10% off of electric bills. Ms. Wall will forward some information to the Town Clerk. Ms. Wall also discussed the solar fields that are planned for County Route 15. Ms. Wall reached out the Mr. McGregor from this project. Mr. McGregor told her that this solar project is still about six to eight months out from being built.

Pam Pucell and Ed Eldridge – Both are new to the area and are trying to familiarize themselves with our Town and Village meetings. They wanted to address an issue of vehicles speeding down Harwood Drive. Sometimes going as fast as 50mph - 70mph past their home. They will reach out to the Village of Sandy Creek since it is inside the Village limits.

Pat McDougal – Mrs. McDougal inquired about the meeting with Fogel and the DEC regarding CEHA. Supervisor Ridgeway stated that Mr. Fogel had postponed the meeting that was scheduled.
